STEP -1

- **Education & Experiences level**
Your education-related teaching activity in an educational or vocational training establishment or research centre, culture and tourism or technical, highly qualified practice in technology and innovation or credible formal education is equal to a degree among holding experience in a similar field



STEP -2

➤ Services or Employment Contract

- **FOR TEACHING ACTIVITY-** Contract of employment or services agreeable, including the teaching activity or Invitation letter from educational or vocational training institution or research centre.
- **FOR HIGHLY QUALIFIED ACTIVITY-** An employment or services contract of at least one year, they agree to an annual remuneration of at least 1.5 times the national average yearly gross salary (1,752.52 euros per month) as well as the designation on management or higher level.
- **FOR CULTURE PROMOTER ACTIVITY -** Work or service contract agreeable with cultural activity (within the scope of a project recognized as of concern to the government in culture promotion). Declaration of the company or entity that carries out the cultural Activity.
- **FOR CERTIFIED COMPANIES*TECH VISA*-** Work or services contract with the term of responsibility area of technology and innovation declared by the certified company (tech visa).




STEP -3

➤ Tax & Social Registration

The Social Security number of Portugal is one of the obligatory identification numbers that will be issued to pay and receive social benefits to or from the state. The state gives it to either a citizen or a legal resident of Portugal.

Obtaining a Portuguese tax number not only to support your visa/ residency application is also a mandatory document to operations buying property, opening a bank account, collocation of legal contracts, getting a loan, getting a job, tax benefits.



STEP -5

➤ Tax & Social Contribution

Tax & social contributions payment applicable taxes & social contribution to the state government for personal as well as representatives. Taxes & social contribution subject to activities of your profession in Portuguese territory.



STEP -6

➤ Checklist of Documents

- Passport valid
- Visa or legal entry documents
- Criminal record from home country
- Criminal record from resident country
- Portuguese tax number
- Portuguese bank account
- Proof of Professionalism in Portugal
- Portuguese social security number
- Accommodation proof in Portugal
- Employment or services contract
- Additional documents



STEP -7

➤ Book An Appointment With SEF

Book an appointment with (SEF) by telephonic call as per your connivance time and date along with location subject to availability.




STEP - 8

➤ Biometric (Fingerprints)

on the appointment day, the applicant obliged to report Portugal immigration authority (SEF) with appropriate documents translate into Portuguese .



STEP -9

➤ Residency Card delivery

The residence card will deliver to your Portuguese home address by post, which will be valid for the next 2 years.
